## Catalog Description:

Surveys major areas of psychology including human development, emotion, learning, memory, intelligence, personality, abnormal behavior, and psychotherapy. Focuses on historical development, research findings, clinical applications, and contemporary issues. Delineates the value of the different areas of psychology to other professions (e.g., medicine, law, business, education). Also, psychological theory and findings are at times placed into a more personal perspective that may relate to the student's own life.

## **Credit Hour Policy Statement:**

#### Standard lecture:

This class meets the federal credit hour policy of 1 hour of class with an expected 2 hours of additional student work outside of class each week for approximately 15 weeks for each hour of credit, or a total of 45-75 total hours for each credit.

## Course Learning Objectives:

By the end of this course, the student should:

- Have an appreciation and understanding for the science of psychology and the scientific method,
- Have a general understanding of various sub disciplines in the field of psychology and their applications to social environments,
- Acquire improved critical thinking and writing skills,
- Be able recognize applications and subsequently apply your acquired knowledge of psychology to various other academic disciplines and life experiences,





#### Methods of Instructions:

This course is primarily a lecture course, although there will be some discussion. Class preparation includes completing all readings prior to class and making notes that will prepare you to discuss the main points, theories, methods, and/or empirical findings from all readings. You should also be prepared to discuss the implications of readings for law, policy, and future psychological research.

# Grading Criteria:

**GRADING:** Grading will be according to a 100-percentage scale: 93 - 100 = A, 90 - 92 = A-, 87 - 89 = B+, 83 - 86 = B, 80 - 82 = B-, 77 - 79 = C+, 73 - 76 = C, 70 - 72 = C-, 67 - 69 = D+, 60 - 66 = D, 60 = F. You will always know exactly where you stand because there is no "curve" and you can calculate your own grade whenever you want by using the formula below. Normal rounding rules apply. Grades will be calculated from the following sources:

## 1. THREE EXAMS = 72% (24% each)

There are 50 multiple-choice questions on all exams. There will be 3 in-class exams on *any* material from lectures, films, discussion section, readings from the text, etc. In addition, there will be a fourth, cumulative exam during the normal university finals week. You are required to take only 3 of the 4 exams. If you take all three exams and are satisfied with your scores, you may skip the final exam. If you missed any one of the first three tests, or want to try to replace your lowest score with a better score, you may take the final exam. I will automatically take the best of your 4 scores. Because the final will cover the entire class, it's in your best interest to take the first three tests. Important: Because you are required to take only 3 exams, THERE WILL BE NO MAKEUP EXAMS. If you have an undocumented absence for *any reason* (are ill, injured, or away) during one of the first three exams, that zero will be your drop score, and you'll simply take the final exam to replace it. No exceptions will be made to this policy. If you miss 2 exams, a zero gets averaged in for a test score and you will probably fail.



#### 2. REACTION PAPERS = 22%

You will have opportunities to write one reaction paper. Handouts explaining this assignment in detail will be posted on Blackboard. Note: No late papers will be accepted, so plan ahead. Papers can be handed in before the deadlines, but not after. The due date is listed below in the syllabus.

## 3. Blackboard SHORT QUIZZES/MINUTE PAPERS = 6%

To help give you an idea of how you are doing throughout this course and to encourage participation, there will be a total of 8 quizzes/minute papers.

**QUIZZES:** The short quizzes will be designed to test your knowledge of the course material and they will be similar to the types of questions you will see on the exams.

MINUTE PAPERS: You will write a brief paragraph about a topic-relevant issue. That is, you will respond to a thought question, requiring no special preparation beyond reading that week's chapter. The purpose of these papers is two-fold. First, these papers will give you an opportunity to think and write about the course material. Minute papers will be graded on an effort-basis. This means you need to put forth effort when writing your minute papers. There is no "minimum" length – that said, do I really think you will be able to complete a minute paper with a couple sentences? No. Give these some thought.

Like any other course requirement, these quizzes/minute papers will be factored into your final course grade. Specifically, if you complete 7 of the 8 quizzes/minute papers, you will receive a full 6% toward your grade. This is like receiving an A for 6% of your total grade, which can really help your average. BUT: If you complete fewer than 7, you will get only .5% per quiz/minute paper. So, for example, if you do only 6 out of the 8 quizzes/minute papers, you will get only 3%, not 6%.

Pat's final is "C." Think about this - she had nearly all B's. If she had done all quizzes/minute papers, Pat would have gotten a 79.86, which rounds up to "B-." Papers, quizzes, and minute papers can bring up test grades.

## Withdrawal and Attendance policies:

Harlaxton College expects regular class attendance by all students. Students are considered sufficiently mature to appreciate the necessity of regular and punctual attendance, to accept this personal responsibility and to accept the consequences of failure to attend. When absences occur due to emergency or medical reasons, students are expected to notify their instructors of the absence prior to class or to seek the assistance of the College nurse or a member of the Student Experience Team for help in notifying instructors.

Instructors have the authority to grant excused absences for medical, psychological, or personal reasons upon review of appropriate documentation and professional recommendation supporting such a request. In the event of long-term illness, reasonable accommodations will be made to allow a student to complete a course. In these cases, the Dean will need to approve the long term nature of the accommodation.

The Dean of Harlaxton College has the authority to grant excused absences for medical, psychological, or personal reasons.

Each instructor is expected to maintain an attendance policy in keeping with the nature of the Harlaxton program and may consider it in evaluating performance in their courses.

## Policy Governing Unexcused Absences:

Harlaxton College operates an attendance policy that is binding on all faculty and students. The number of unexcused absences that are allowed before incurring a penalty is related to the number of times a class meets each week. For courses which meet three times a week, students are allowed a maximum of three unexcused absences during the semester without attracting penalty points. For courses meeting twice a week two such absences are permitted, and for courses meeting once a week a single absence is allowed. Additional unexcused absences will attract a grade penalty.

The penalty for unexcused absences will be a full-letter grade deduction.

## Policy Governing Excused Absences.

- Excused absences are not given to facilitate student travel independent of College-sponsored travel.
- Students may be permitted to miss class because of participation in academic field trips.
- Instructors must co-ordinate and confirm academic fieldtrips with the Dean, prior to the commencement of the Semester to ensure their inclusion in the Semester timetable.
- Where authorization for an academic fieldtrip is requested after the commencement of the semester, the request must be submitted to the Dean.



The following information is required:

- Purpose and brief description of the official Harlaxton event or academic fieldtrip.
- Dates, location, and times (as applicable).
- Alphabetical list of students involved [Last Name/First Name] along with their student identification number.

#### If approval is granted:

- Instructors affected will be notified at least one week prior to the class period during which absence is anticipated, or as soon as possible.
- Missed class time due to student participation is to be considered an excused absence.
- The grade of a student may not be lowered in any class due to excused absences.
- It is the student's responsibility to take the initiative by consulting with their instructors before the absence occurs, and to do what is required by the instructor to make up all missed assignments and/or examinations.
- Instructors are required to assist students in these occasional situations of excused absences.

#### Honor Code:
