Course Information

Course Description

The Victorian era was not gray or sleepy, as many 21st-century readers assume. Rather, it was full of contradiction, debate, and rebellious figures. In this class, students read 19th-century literature with a focus on British novels. We will focus on understanding how the Victorians questioned and developed concepts that remain central to human experience. How did Victorians represent and define race? How do stories about scandalous marriages comment on restrictive laws? What do rebellious fictional wives tell us about feminism in the nineteenth century? How does detective fiction interrogate race? What do domestic servants reveal about family structures and labor dynamics? As we work collaboratively to develop answers to the questions above, students will closely analyze textual details as they build strong critical analyses in class discussion as well as written assignments.

Catalog Description

Explores British literature from 1837 to 1901, with emphasis on the Victorian writer as poet, sage, and novelist. Includes such authors as Barrett, Browning, Tennyson, Newman, Gaskell, and Dickens.

Credit Hour Policy Statement

Standard lecture: This class meets the federal credit hour policy of 1 hour of class with an expected 2 hours of additional student work outside of class each week for approximately 15 weeks for each hour of credit, or a total of 45-75 total hours for each credit.

Course Learning Outcomes

- Close reading/close analysis skills, as evidenced in written assignments and class discussion.
- Clear, cogent writing that follows MLA standards.
- Conduct academic research.
- Coherent verbal presentation of research.
- Knowledge of the 19th-century British history covered in lectures and readings.

Methods of Instruction: Lectures, in-person discussion, reading quizzes, written papers, verbal presentations.

Grading Criteria

- 25% Daily Verbal Participation
 - 25% Reading Quizzes
 - 25% Analysis Papers (4-5 papers, 2-3 pages in length)
 - 25% Final Presentation and Annotated Bibliography
- *Attendance also affects your final course grade. See policies below.

All assignments are scored on a 100-point scale, and I will provide detailed assignment sheets well in advance of due dates. Reading quizzes are straightforward and usually not difficult if you have completed the reading with attention. For written assignments, completing all assignment requirements and doing average work earns a grade in the "C" range. Doing a written assignment well (with a minimum of mistakes, weak areas, or errors) earns a score in the "B" range. Impressive written work that achieves the assignment goals with distinction earns a score in the "A" range.

Class Participation and Preparation

You are expected to do the assigned reading before each class meeting and to bring the reading with you to class (printed copies of the shorter readings and print books, not e-books). Come to class prepared to engage in a lively discussion. To accomplish our goals and to have as much fun as possible this semester, it is essential for every class member to contribute to discussion. Arrive with comments or questions, and be ready to speak.

Participating in class not only helps you to learn but also contributes to the learning of other students. When it comes to participation, good listening skills are as important as good speaking skills. All students are responsible for maintaining a respectful environment. Any disruptive or disrespectful activity will result in substantial lowering of your participation score, and I may ask you to leave the class. Such activities include phone activity of any sort, sleeping, arriving late, leaving early, reading or doing work for other courses, and having “side conversations” with classmates. Unless you have been given permission from the professor, you should not have a laptop computer open during class meetings. Students routinely report that the real-time, face-to-face, shared focus of our classroom – without the distractions of screens or phones – is an element of their university education that they value most highly.

Withdrawal and Attendance Policies

Harlaxton College expects regular class attendance by all students. Students are considered sufficiently mature to appreciate the necessity of regular and punctual attendance, to accept this personal responsibility and to accept the consequences of failure to attend. When absences occur due to emergency or medical reasons, students are expected to notify their instructors of the absence prior to class or to seek the assistance of the College nurse or a member of the Student Experience Team for help in notifying instructors.

Instructors have the authority to grant excused absences for medical, psychological, or personal reasons upon review of appropriate documentation and professional recommendation supporting such a request. In the event of long-term illness, reasonable accommodations will be made to allow a student to complete a course. accommodation. In these cases, the Dean will need to approve the long-term nature of the accommodation.

The Dean of Harlaxton College has the authority to grant excused absences for medical, psychological, or personal reasons. Each instructor is expected to maintain an attendance policy in keeping with the nature of the Harlaxton program and may consider it in evaluating performance in their courses.

Policy Governing Unexcused Absences

Harlaxton College operates an attendance policy that is binding on all faculty and students. The number of unexcused absences that are allowed before incurring a penalty is related to the number of times a class meets each week. For courses which meet three times a week, students are allowed a maximum of three unexcused absences during the semester without attracting penalty points. For courses meeting twice a week two such absences are permitted, and for courses meeting once a week a single absence is allowed. Additional unexcused absences will attract a grade penalty. In this class, any unexcused absence beyond two will result in a half-letter grade deduction [a student with 3 unexcused absences would forfeit 5 points on the 100-point scale, so a final course grade of 90 (A-) would be lowered to 85 (B).]

Policy Governing Excused Absences

- Excused absences are not given to facilitate student travel independent of College-sponsored travel.
- Students may be permitted to miss class because of participation in academic field trips.
- Instructors must coordinate and confirm academic field trips with the Dean, prior to the commencement of the Semester to ensure their inclusion in the Semester timetable.
- Where authorization for an academic field trip is requested after the commencement of the semester, the request must be submitted to the Dean.

The following information is required:

- Purpose and brief description of the official Harlaxton event or academic fieldtrip.
- Dates, location, and times (as applicable).
- Alphabetical list of students involved [Last Name/First Name] along with their student identification number.

If approval is granted:

- Instructors affected will be notified at least one week prior to the class period during which absence is anticipated, or as soon as possible.
- Missed class time due to student participation is to be considered an excused absence.
- The grade of a student may not be lowered in any class due to excused absences.
- It is the student's responsibility - to take the initiative by consulting with their instructors before the absence occurs, and - to do what is required by the instructor to make up all missed assignments and/or examinations.
- Instructors are required to assist students in these occasional situations of excused absences.

Honor Code

All students at the University of Evansville agree to the University honor code: *I will neither give nor receive unauthorized aid, nor will I tolerate an environment that condones the use of unauthorized aid.* If you witness another student using unauthorized aid, you are obligated to report the incident.

Course AI and Academic Integrity Policy

In this course, submission of any work that is not entirely your own is considered academic dishonesty. The use of generative AI tools such as ChatGPT are prohibited and constitute a violation of academic integrity as examples of unauthorized aid. Online translators and writing aids, such as Grammarly, are

also prohibited. "Synonym copying" is also a form of plagiarism. If you have questions about online writing aids, please ask your professor.

Any paper (whole or in part), regardless of its quality, that is plagiarized, uses sources that are not cited, or is determined not to be the work of the cited author will receive an "F," and the student will receive an "F" in the course. Using books, study aids, or notes during quizzes or exams, or looking at someone else's answers, is prohibited.
